The Historical Society of Southern California was founded on November 1, 1883, and incorporated February 13, 1891. It has enjoyed an unbroken record of continuous activity and growth. Commencing in 1884, and each year through 1934, the society issued an *Annual Publication*. In 1935 *The Quarterly* (later renamed the *Southern California Quarterly*) was initiated. The Society's publications through 1976 have been indexed and described in a concise abstract of articles by Anna Marie and Everett Gordon Hager (comps.), *A Bibliography* (1958), *The Topical Index* (1959), and *Cumulative Index* (1977). The current issue and all back issues are available online to members of the Society (regular level and higher) and through subscribing libraries.

Julian Delgaudio taught history at Long Beach City College for over twenty years. As a way of interesting his students in the decision-making processes of local government, he used research on the effects of World War II in Long Beach. His work on the subject led to successful exhibition projects for the Historical Society of Long Beach, of which he was a board member. He died unexpectedly in August of 2015 and their article in this issue was completed by Craig Hendricks.

Craig Hendricks taught history for over two decades at Long Beach City College. His research for this article began while collaborating with colleagues (including Julian Delgaudio) and K-12 teachers on the role of the federal government on the historical development of Long Beach. He is a board member of the Historical Society of Long Beach. He has worked on various exhibitions and Long Beach Community Studies conferences for the HSLB and remains active in the society since his retirement from teaching.

Karl Jacoby is Professor of History and in the Center for the Study of Ethnicity and Race at Columbia University, specializing in environmental, borderlands, and Native American history. His books include *The Strange Career of William Ellis: The Texas Slave Who Became a Mexican Millionaire* (2016), *Shadows at Dawn: A Borderlands Massacre and the Violence of History* (2009), and *Crimes against Nature: Squatters, Poachers, Thieves, and the Hidden History of American Conservation* (2001).

Alessandra Lorini completed the PhD at Columbia University and taught North American history and History of Inter-American Relations at the University of Florence, Italy, for three decades. She has published extensively, most notably, *Rituals of Race: American Public Culture and the Search for Racial Democracy* (Virginia University Press, 1999), *Ai confini della libertà: saggi di Storia americana* [At the Borders of Freedom: Essays on American History] (Donzelli, 2001), *L'impero della Libertà e l'isola strategica. Gli Stati Uniti e Cuba tra Otto e Novecento* [The Empire of Freedom and the Strategic Island: The United States and Cuba in the Late Nineteenth and Early Twentieth Centuries] (Firenze University Press, 2005). She is presently working on a book on Father Kino.

Serena Luzzi is Associate Professor of Modern History in the Department of Sociology and Social Research at the University of Trento (Italy). She is the author of several articles on Father Kino. Among her current research interests is the role of Catholic missionaries in legitimating war in colonial America in the seventeenth and eighteenth centuries.
